



TEAM MEMBER AGREEMENT

In order to finalise you or your child's position within the team you must read, understand and sign the Club Agreement.

Please read all of the statements and sign the Club Agreement to show that you have read and understood this agreement.

Parents/Guardians are to ensure their child is aware of both the Code of Conduct and Social Media Guidelines. Both Parents/Guardians and Members must sign the Club Agreement form.

- I understand that this document is a legally binding agreement for my child or myself to participate as a member of a Windsor Calisthenics Club team and be registered with the Calisthenics Association of South Australia (CASA).
- I have read the Club Policy and this Agreement and fully accept and will comply with it.
- I understand that is a condition of remaining in the team that I comply with this Agreement at all times.
- I understand the penalties and consequences should I break my condition.
- I have read and will abide by the following Social Media terms and conditions:
 - I agree to not upload Team photos and Competition and Concert DVDs onto social media sites.
 - I understand that any video footage / photos / other images taken may be shown in a public environment (in SA / interstate / and/or overseas).
 - I agree that my child's participation in promotional activities may be edited at the sole discretion of the Windsor Calisthenics Club Committee.
 - I acknowledge that the Windsor Calisthenics Club Committee is not obliged to include my child in the promotional activities.
 - I release the Windsor Calisthenics Club Committee from any claim by me or anyone on my behalf arising out of my child's appearance in promotional activities.
 - I acknowledge that there is to be no payment or further consideration paid for my child's performance.
 - I am aware that the Windsor Calisthenics Club will use my photos / film footage in good judgement and as agreed to by me and that I have the right to revoke permission for use. This revocation does not apply to printed / film media that has already been produced and released, but applies to subsequent productions.
- I understand that Windsor Calisthenics Club enforce the following codes under the Member Protection Policy and the CASA Rules and I agree to comply with them:
 - The General Code of Behaviour
 - The Parent/Guardian Code of Behaviour
 - The Participant Code of Conduct
 - Social Media Guidelines and Media Terms and Conditions
- I agree to pay all costs associated with team membership as set out in this Agreement in a timely manner and as determined by the Executive Committee.
- I understand that an absence from lesson for any reason will not result in a refund of fees for those lessons.
- I understand that the Coach is the main contact for each team and all communications must be conducted through the coach in the first instance.
- I understand that if I do not comply with injury assessment procedures I will be removed from the team.
- I understand that if I withdraw from the team I am not entitled to a refund of the Registration fee. I will be eligible to receive a refund of the remainder of fees paid as well as Costume fees where costs have not been incurred.
- I agree to abide by Windsor Calisthenics Club Constitution, Rules, Policies, Codes of Conduct and any decisions of the Executive Committee.
- I also agree to abide by any applicable Rules, Policies, Codes of Conduct and decisions of the Calisthenics Association of South Australia Inc.
